## **Application Instructions**

- Clean seed treating equipment and mix tank thoroughly before use. Ensure there is no residual water in the mix tank. Calibrate seed treater per standard procedures.
- Ensure biotrinsic<sup>™</sup> microbial inoculant is well mixed before adding to the mix tank. The product is a suspension of microbes and some settling is normal.
- Add the biotrinsic<sup>™</sup> microbial inoculant to the mix tank. Keep product agitated once added to the mix tank.
- If necessary, dilute the biotrinsic<sup>™</sup> microbial inoculant with non-chlorinated water and increase the application rate by an amount proportional to the dilution. Allow time and agitation to achieve uniformity. Once the biotrinsic<sup>™</sup> microbial inoculant is diluted, it must be used within 8 hours.
- If desired, the biotrinsic™ microbial inoculant can be tank mixed with fungicides, insecticides, pesticides, polymers, or other seed
- treatments. Once the biotrinsic<sup>™</sup> microbial inoculant is tank mixed, it must be used within 8 hours.
- The seed treatment equipment and mix tank can be cleaned using a water rinse or an alkaline detergent. If necessary, the mix tank can be cleaned with 2% bleach to decrease microbial load.

## Storage

• DO NOT allow biotrinsic<sup>™</sup> microbial inoculant to freeze. If possible, store at 40°F. If refrigeration is not possible, store in a cool location away from direct sunlight below 75°F in its original container.

- Segregate from food and animal feed.
- Keep away from children.

#### Disposal

• Follow any and all local, state, and federal waste disposal guidelines for inoculants and plant amendments.

- DO NOT discharge into drains, surface water, or groundwater.
- For small releases contain the product with dust binding material and dispose of as per local regulations for inoculants and plant amendments.

• For large releases contain the product with an absorbent material and dispose of the absorbed material as per local regulations for inoculants and plant amendments.
